SUB-FLOOR REQUIREMENTS

Sub-floors must be flat and structurally sound. All paint, varnish, oil, wax, finishes and any other bond inhibiting substances must be removed. Smooth or glazed surfaces must be abraded. Repair all joints and cracks with latex-based portland cement underlayments.

- Above, On, and Below grade concrete
- (Maximum moisture emission rate of 5lbs./1000 sq.ft./24 hours, a pH of 7-9.0, RH<75%)
- APA rated plywood underlayment
- Properly prepared gypsum cements

NOTE: Particleboard is **not** a recommended underlayment. Strip or plank wood flooring and OSB sub-floors must be covered with an approved underlayment (minimum thickness of 1/4"). Graphics Unitary or Double-Glue (Carpet to Pad): 1/8" x 1/8" x 1/16" U notch, 50 sq. ft./gal.

Woven polypropylene, BioCel Laminate®, EnviroCel®, unitary w/ActionBac® (HP SBR Latex with attached woven secondary: 1/8" x 1/8" x 1/8" U notch, 100 sq. ft. /gal.

Attached Cushions; BioCel®: 3/32" x 3/32" x 3/32" V notch, 125 sq. ft./gal.

NOTE: We recommend installers follow the guidelines set forth in CRI 104 and Signature Flooring specific recommendations. Before placing the carpet, the adhesive must be allowed an open or dwell time appropriate for the carpet backing, jobsite and sub-floor conditions. It is extremely important to maintain recommended notch depth, width and spacing. The proper notch depth is that which will produce adhesive ridges that affect a 100% transfer to both the substrate and the carpet backing to include the inner recesses of the texture of the back.
